This grant provides grantees with the resources required for implementation of the National Preparedness System and working toward the National Preparedness Goal of a secure and resilient nation. The County has received funding from this grant program since 2002.

F	f accepted, the County will deobligate \$192,617 from the Community Preparedness and Regional Planning award due to award closure. The funds will be reallocated to the Fire Marshal's Office HazMat award to impact the County's ability to communicate, detect, and decontaminate during their response to terrorist events and other emergencies.
