Request by Juvenile Probation for approval to temporarily transfer general funds in the amount of \$80,000 to the grant account pending receipt of the award from the Office of the Governor, Criminal Justice Division for the Girls Inspiring Future Triumphs (GIFT) Program, and to reclassify one position and extend all associated grant positions to September 30, 2022.

Background and Discussion:

The awarding of this renewal grant may be delayed by the grantor but it is anticipated that we will receive this award in October 2021. When the award is received, the transfer will be reversed and expenditures will be charged to the grant retroactive to October 1, 2021.

Expected Impact:

This temporary budget transfer will ensure continuity of the Girls Inspiring Future Triumphs (GIFT) Program which provides services to female victims of human trafficking by providing funds to cover payroll expenses for three of the staff members working with the program. The request for a temporary transfer of funds will cover 3 months of salaries and fringe of staff until the award is received.
