Request for approval of an agreement with Baylor College of Medicine for the purpose of establishing and implementing a health literacy program involving the facilities and personnel of HCSO and BCM students.

Background and Discussion:

Baylor College of Medicine (BCM) operates a medical school that provides academic programs and courses with respect to healthcare. BCM, through its students on a strictly volunteer basis desires to offer health classes to the incarcerated population at Harris County jail with the aim of increasing health literacy. Harris County Sheriff's Office (HCSO) desires to cooperate with BCM to establish and implement a health literacy program involving the facilities and personnel of HCSO.

Expected Impact:

With approval of the agreement of affiliation, HCSO will be able to obtain volunteer medical students to teach health classes to inmates. These health classes can increase the inmates' knowledge and understanding of common medical illnesses seen in Harris County and particularly in the incarcerated population. The program

will also expose medical students to the field of Correctional Healthcare and help them better understand the need for knowledgeable and compassionate physicians to work in correctional healthcare. This exposure may lead to an increased understanding of the unique field of correctional medicine and may also lead to an increased number of medical students choosing a career in Correctional Medicine, caring for incarcerated patients.
