#### Request Summary (Agenda Caption):

Request by Public Health Services for approval to accept from the U.S. Department of Health & Human Services renewal grant funds in the amount of \$300,000, with no required match, and extend three associated positions to September 29, 2023 for the FY 2022-23 Childhood Lead Poisoning Prevention and Surveillance Program.

#### **Background and Discussion:**

Harris County Public Health (HCPH) was awarded and received funding from CDC to develop programs and policies to prevent childhood lead poisoning and other housing related health hazards. To date, HCPH has initiated several lead poisoning prevention and lead education activities in the community by partnering with organizations to provide lead presentations and attending outreach events in vulnerable populations. In addition, the program has developed case coordination services to families of children with elevated blood lead levels.
