#### Request Summary (Agenda Caption):

Request for approval of an encroachment agreement with Tennessee Gas Pipeline, L.L.C., to construct, own, operate, maintain, use and remove a larger fully paved weir to replace the existing weir in support of the District's Upper Langham Creek Frontier Program. (Addicks Reservoir Watershed, Bond ID F-54, Project ID U100-00-E009, Agreement No. 2022-120, Precincts 3 and 4).

#### **Background and Discussion:**

The Upper Langham Creek Frontier Program provides regional detention benefit for new development within the program service area based on 2012 court-approved program guidelines. The service area extends from John Paul Landing basin at the upstream end to Greenhouse basin at the downstream end. Development is ongoing along Langham Creek just downstream of SH99. A control structure is proposed over Kinder Morgan's existing Tennessee Gas Pipeline crossing to provide hydraulic benefit to the program. Kinder Morgan requires an encroachment agreement for construction of the control structure.
