The Preparation for Adult Living (PAL) contract provides services to youth between the ages of 14-20 who are transitioning out of foster care. The HAY Center serves as the transition center for region 6 and has managed this contract for several years.

**Expected Impact:**

Foster youth enrolled in aftercare services will be eligible to receive a stipend ranging from \$750 to \$5,500 to provide financial support due to the global pandemic.
