Background and Discussion:

Precinct has continued to develop their roadway rehabilitation program and is preparing to improve roadways along Cline Rd, Winfield Rd, Nightingale Dr, and Forest Acre Dr.

Project consists of roadside ditch improvements, rehabilitation, or full depth reconstruction of approximately 15,140 ft. (2.87 Miles) of asphalt roadway.

Expected Impact:

Reconstruction and rehabilitation of the proposed roadways will improve drainage and pavement conditions.
