Background and Discussion:

The Harris County Precinct 2 Parks and Trails Plan was recently developed in 2019 to guide the Precinct on parks and trails planning. Developed with the community and key stakeholders, the plan outlines a long-term vision and near-term plan for priority investments in parks and trails.

This year the precincts within Harris County went through a redistricting process. The result of this has changed the boundary of Precinct 2 to encompass parts of what was previously Precinct 1.
