Request Summary (Agenda Caption):

Request by Human Resources & Risk Management for approval to execute a parking agreement with SP Plus Corporation to pay for parking at 1101 Fannin Street, Houston, Texas 77002 for employees officing at 1111 Fannin.

Background and Discussion:

Human Resources & Risk Management recently moved to 1111 Fannin. Parking is necessary for successful operations of Human Resources & Risk Management. The facility will have an estimated total seat count of between 2,063 and 2,898; however, there are approximately only 470 parking spaces available in the building. The attached agreement is for vouchers ("chaser tickets") to be used by employees including contract employees who work a hybrid remote schedule.

Expected Impact:

The additional spaces will alleviate a shortage of parking available at 1111 Fannin once the building is fully

occupied. The cost to lease a parking space at the 1101 Fannin garage is \$165 per month. The use of a voucher is a lower cost option for those employees working a hybrid remote schedule.
