Request Summary (Agenda Caption):

Request for approval to execute a Joint Participation Interlocal Agreement with Fry Road Municipal Utility District to construct Sidewalk Project - Park Row, Price Plaza and Snake River Road - 2021 and all related appurtenances, UPIN 211033961130037, Precinct 4.

Background and Discussion:

The agreement will allow the Fry Road Municipal Utility District to reimburse Harris County for all cost associated with their portion of the overall project. Summary of reimbursement is below the Fiscal and Personnel Summary Table and in the attached Agreement.

The scope of this project includes:

Design and construction management of a 5' wide concrete sidewalk along 4 segments of Roadway:

- North side of Park Row from Price Plaza to Fry Road
- West side of Price Plaza from IH 10 to Park Row

- East side of Snake River Road from Park Row to about 800' north of Park Row
- South side of Park Row from Price Plaza to Fry Road

Construction of wheelchair ramps at all public street intersections, sloped driveways and retaining walls, where grade behind the curb is steep. Driveways that do not meet Harris County's or TDLR's rules and regulations are to be removed and replaced with proper slopes.

Expected Impact:

Ability to design and construct the "Sidewalk Project - Park Row, Price Plaza and Snake River Road - 2021", thereby improving mobility and safety for pedestrians. Allow the Fry Road Municipal Utility District to reimburse Harris County for all cost associated with their portion of the overall project.

Alternative Options:

Harris County would not be reimbursed by the Fry MUD for their portion of the project without the interlocal Agreement. Potential delay in the project due to funding.
