The mechanical, electrical, plumbing (MEP), and fire protection systems at Annex 26 are old and have reached their end of life. The consultant on this project will provide services consisting of architectural and MEP engineering design for the entire Annex 26 facility. This project is listed on the Capital Improvement Plan list for FY23.

#### **Expected Impact:**

Completion of this project will increase the reliability of the building's critical infrastructure systems. This project will also prevent catastrophic MEP systems failure and disruption of service.
