Request by Juvenile Probation for approval to accept an amendment to an agreement with the Texas Education Agency to increase the grant award by \$6,056, with no required match, for the GY 2023 Title II-Part A-Improving Teacher Quality Program.

Background and Discussion:

The Texas Education Agency has awarded additional funds to the Excel Academy Charter School. Based on federal guidelines, these funds are being re-directed to meet a Title I-Part A purpose that is to provide all children a significant opportunity to receive a fair, equitable, and high-quality education. The Harris County Juvenile Board has accepted these funds. The funds are for the period beginning July 1, 2022 and ending September 30, 2023.
