Change Includes bid item # 005 - Camp maintenance at 8103 Wade Road, Baytown, TX 77521: Finished mowing, edging, trimming, trash removal, trimming plants/shrubs, general lawn maintenance, and mulching once per year, with a quantity of 22 service visits, and with the unit price of \$1,040.00 per visit.

The new bid item is intended to establish the unit price and there is no change to the term contract value.
