These guidelines were drafted with input and approval from Housing and Community Development (HCHCD) staff and from the Treasury ARPA Housing Focus Area Team and Steering Committee. HCHCD seeks approval of these operational guidelines for the purpose of beginning the Single-Family Acquisition/Development and Resale Program Guidelines for the Treasury ARPA-Affordable Housing Portfolio.
