#### Request Summary (Agenda Caption):

Request by the Office of the Purchasing Agent that the County Judge execute an amendment to an agreement with Kids' Meals, Inc. for pilot or expand early childhood programs through the Early Childhood Impact Fund for Harris County for the extended period of June 6, 2025 - December 5, 2025, with no increase in the total contract amount (220410), Justification for 0% MWDBE Participation Goal: 0% - Non-Divisible.

#### **Background and Discussion:**

In October 2020, Commissioner's Court approved \$10 million in Harris County general funds for the Early Childhood Impact Fund, designed to invest in programs and interventions with significant potential to dramatically improve early childhood outcomes in Harris County. The goals of the fund include:

• Invest in the most promising, cost-effective, evidence-based solutions for improving early childhood outcomes in Harris County

- Build a stronger, more seamless network of early childhood service providers
- Prioritize rigorous data collection and evaluation
- Create pathways to long-term, scalable impact for further investment

The County released an RFP in late 2020 to solicit applications from service providers, organizations, and researchers to implement a three-year program. Three organizations were selected to receive funding: The Alliance, First3Years, and Texas Children's hospital. The organizations were selected to implement the following programs:

• Kids' Meals will receive an additional six (month) contract extension to expand their healthy meal delivery program to children and families in Harris County. The organization aims to end generational poverty by providing children with meals until they reach kindergarten thus negating low school engagement, substandard academic development, and poor emotional and physical health.

#### **Expected Impact:**

The approval of this amendment will enable Kids' Meals Inc. to start implementation of Early Childhood Impact Fund services with all pre-award documentation completed under the updated department.
