#### Request Summary (Agenda Caption):

Request by the Office of County Administration for approval of four positions effective May 4, 2024 in support of the American Rescue Plan Act (ARPA) Local Fiscal Recovery Fund program administration, with a total budget of \$1,927,236.

### **Background and Discussion:**

In 2021, the U.S. Treasury allocated \$915.5 million in Coronavirus Local Fiscal Recovery Funds to Harris County. Since then, Commissioners Court has approved over \$870 million in program spend across over 80 projects, with more under development. Currently, limited internal resources are dedicated to program administration. Additional support is required to ensure programs deliver target outcomes and fully comply with US Treasury regulations.
