Request Summary (Agenda Caption):

Request for approval to negotiate with DEC Corp. for professional engineering services in connection with Arcadian Gardens Phase 1, UPIN 24103MF3E801, Precinct 3.

Background and Discussion:

The Arcadian Gardens Phase 1 project in Barrett Station aims to transform narrow roads into 22' wide concrete roadways with curbs, gutters, and sidewalks, enhancing pedestrian safety and accessibility. The project involves a phased renovation plan that includes comprehensive drainage solutions like a detention basin and coordinates with an ARPA street lighting project. Key elements involve road and drainage rehabilitation, right-of-way assessments, detailed construction drawings, and public engagement to improve community connectivity and ensure alignment with regulatory requirements.

Expected Impact:

The Arcadian Gardens Phase 1 project will transform Barrett Station by widening roads to 22 feet and adding safety features to boost pedestrian accessibility and reduce flood risks. These improvements aim to alleviate traffic, enhance local drainage, and attract business investments.
