### Request Summary (Agenda Caption):

Request for approval to update the current list of charities or programs for jurors who wish to donate their juror pay.

### Background and Discussion:

Texas Government Code §61.003 prescribes provisions relating to the donation of a prospective juror of the daily reimbursement for jury service. As required by the law, currently four programs are statutory as options for consideration by Jurors: (1) Victims of Crime Fund, (2) Children's Protective Services Child Welfare Service Fund, (3) Harris County Veterans' Treatment Court and (4) Veterans County Service Office. This statute also includes a provision for any program selected by commissioners' court that is operated by a public or private nonprofit organization and that provides shelter and services to victims of family violence; any other program approved by the commissioners' court of the county, including a program established under Article 56A.205, Code of Criminal Procedure, that offers psychological counseling in criminal cases involving graphic evidence or testimony.
