Request for approval of a right-of-way consent agreement with ExxonMobil Pipeline Company, to provide for the removal of accumulated sediment to original bayou depth, lay cement and rip/rap under and across its pipeline support bridge and easement near HCFCF Unit No. E100-00-00, White Oak Bayou Crossing, White Oak Bayou Watershed, Bond ID C-14, Project ID E100-00-00-E005, Agreement No. 2022-61, Precinct 4.

Background and Discussion:

The White Oak Bayou Federal Project is performing channel modifications within this segment of the bayou, from Hollister to FM 1960. ExxonMobil has a pipeline easement that crosses the bayou. HCFCF requires this agreement to make channel modifications within the pipeline easement.

Expected Impact:

The channel modification within this project will reduce the risk of flooding along White Oak Bayou.
