Request Summary (Agenda Caption):

Request by Community Services for approval to submit an application to the U.S. Department of Housing & Urban Development for grant funds in the amount of \$964,570, with a required match of \$241,143, for the FY 2021 Permanent Housing Program.

Background and Discussion:

HUD released the Notice of Funding Availability (NOFA) for the Fiscal Year 2021 Continuum of Care Program Competition on August 19, 2021. For the Houston/Harris County Continuum of Care (The Way Home Continuum of Care), the collaborative applicant is the CoC lead agency, the Coalition for the Homeless of Houston/Harris County (Coalition). Ranking and application submission are done through approval of the Continuum of Care Steering Committee.

The Continuum of Care Program funds are used to provide rental assistance to homeless persons with serious mental illness, chronic problems with alcohol or drugs, or HIV/AIDS. The goal is to lead homeless persons toward economic self-sufficiency and independence. In addition, this program provides funds for eligible homeless persons with severe disabilities.

HCCSD requests approval for Harris County to apply for the renewal grant for FY2021 CoC Northline project in the amount \$964,570 to renew the CoC Northline grant for the purpose of providing a safe living environment through 53 scattered-site permanent supportive housing units for homeless men and women throughout Harris County.
