Request for approval of orders authorizing acceptance of payments in connection with settlement of damages to county equipment and property in the total amount of \$57,443 and two workers' compensation recoveries in the total amount of \$5,709; tort claim and other settlement recommendations in the amount of \$15,714; denial of 33 claims; claims for damages received during the period ending October 5, 2021; and that the County Judge execute one release in exchange for payment to the county in the amount of \$3,884 in connection with a property damage claim.
