Request for approval of a renewal option with Caring Commercial Cleaning Inc. for custodial cleaning services in Region 1 for Facilities & Property Maintenance for the period of December 19, 2021 - December 18, 2022 at a cost of \$658,706, subject to applicable bonds to be received (170032).

This agreement has provided janitorial services to Harris County owned locations operated and maintained by FPM. The services included routine cleaning and floor maintenance services as well as some special cleaning and biohazard services.
