Request for approval of a renewal option with Bear Services LP for maintenance and repair of petroleum storage tank systems associated with fueling operations and used oil storage and related items for Harris County for the period of August 11, 2022 - August 10, 2023 at a cost of \$100,000, and for the County Clerk to execute any applicable bonds to be received (200143), Justification for 0% MWDBE Participation Goal: N/A - project was awarded prior to launch of County's M/WBE Program.

**Background and Discussion:**

This request is the annual renewal of a 5-year contract entitled Maintenance and Repair of Petroleum Storage Tank Systems Associated with Fueling Operations and Used Oil Storage and Related Items

**Expected Impact:**

The Harris County operators of underground and aboveground petroleum storage tanks (fuel stations, used oil, and emergency generators) will have continued access to on-call services pertaining to the maintenance and repair of associated equipment.

Harris County would be required to obtain three informal bids, or formally bid, each time maintenance or repair is needed. This contract is also for emergency repairs; without this contract, it would be difficult to obtain additional quotes if the repair is critical.
