Request for approval to execute an agreement with Sirrus Engineers, Inc. in the amount of \$137,031.00 for Professional Engineering and related Services to construct sidewalk and access management improvements to Ella Boulevard from Richey Road to FM 1960, UPIN 21208MF21401, Precinct 1, MWDBE Contracted Goal 62%.

**Background and Discussion:**

The project is to improve Ella Boulevard from West Richey Road to FM 1960, approximate 1.5 miles, consisting of the mill and overlay of existing asphalt pavement, access management measure installation, sidewalk on each sides, METRO bus stops, three new signals, and storm sewer for North Forest Subdivision drainage improvement.

The proposed improvement will provide the safer condition for both traffic and pedestrian. Provide the safe route to school.
