Request for approval to establish a discretionary match in the amount of \$15,000.00 for the FY 2019 Port Security Grant Program.

Background and Discussion:

This grant provides funding to state, local and private-sector partners to help protect critical port infrastructure from terrorism, enhance maritime domain awareness, improve port-wide maritime security risk management, and maintain or reestablish maritime security mitigation protocols that support port recovery and resiliency capabilities. On May 10, 2022, the Court approved an extension of this grant and this request will put funding towards that grant extension.
