Request Summary (Agenda Caption):

Request by the Flood Control District for approval to accept an amendment to an agreement with the Texas Water Development Board to extend the end date to June 30, 2023 for the FY 2016 Flood Mitigation Assistance Program.

Background and Discussion:

Harris County Commissioners Court granted the Flood Control District permission to accept this grant award on November 14, 2017. This amendment extends the grant end date from September 2, 2022, to March 2, 2023, allowing additional time to purchase flood-prone homes with federal grant funds.

Expected Impact:

Provides more time to purchase homes located in approved HCFCD buyout areas.
