Request for approval of a change in contract with Hayden Paving, Inc. in connection with Maintenance - BS2N Baytown South 2021, with no change in the amount, Job No. 21/0411-2, UPIN 22102MF25501, Precinct 2, MWDBE Contracted Goal: 11%, MWDBE Current Participation: 13%.

#### **Background and Discussion:**

Project includes the repair of asphalt pavement throughout the Baytown South area for the BetterStreets2Neighborhoods Community Program for Harris County Precinct 2. Change includes quantity adjustment on two bid items required to complete the base repairs for the project.

#### **Expected Impact:**

Change allows contractor to perform base repairs with Hot-Mix Asphalt Type A instead of Hot-Mix Asphalt Type B; and adjusting the scope of work due to the poor existing conditions on the remaining roads.
