Request Summary (Agenda Caption):

Request for approval to execute an Agreement with Halff Associates, Inc. to provide professional engineering design services for the permanent transition of Toll Road Operations to an all-electronic roadway environment for the Sam Houston Tollway Segment #3 - South, in Harris County, Texas in the amount of \$8,802,000 (Precincts 3 and 4). MWDBE Contracted Goal: 35%.

Background and Discussion:

As part of the implementation of the All-Electronic Tolling program, the Harris County Toll Road Authority intends to procure the professional services of qualified engineers to provide engineering and planning services.

The May 24, 2022 Commissioners Court approved the negotiation with Halff Associates, Inc. to provide engineering design services for the proposed improvements related to the Sam Houston Tollway Segment #3 - South, in Harris County.

Expected Impact:

The professional service contract will permit HCTRA to support the system planning, engineering, sustainability, tolling, and development of business rules for the conversion to All-Electronic Tolling.
