Request for approval of certain projects, decreeing the projects to be a public necessity and convenience, directing the Harris County Real Property Division to acquire, and authorizing eminent domain, if necessary, for one (1) fee simple tract, for the public project known as 1101 Fannin Parking Garage, for the purpose of additional parking, UPIN 23208MF2RE01, Precinct 1.

**Background and Discussion:**

On April 27, 2021, Commissioner's Court authorized the purchase of the 1111 Fannin building for use to consolidate county operations into a single location. As part of the 1101 Fannin Parking Garage project, Commissioners Court must declare the public necessity to acquire said parking garage for the purpose of providing additional parking for 1111 Fannin.

**Expected Impact:**

Acquisition of the property will allow for additional employee and visitor parking at the 1111 Fannin location.
