Request Summary (Agenda Caption):

Request for approval of an agreement with the Houston Livestock Show and Rodeo, Inc. (HLSR) to use MOD K9 Teams as a security measure during the 2024 HLSR season with overtime reimbursed by HLSR.

Background and Discussion:

The Houston Livestock Show and Rodeo has been a Greater Harris County Event since 1932, and now draws approximately 2 million visitors during the rodeo season. The Sheriff's Office has provided the use of MOD K9 Teams during the event in 2019, 2022, and 2023.

Expected Impact:

The addition of the MOD K9 Teams will provide an added layer of security for patrons who attend the Houston Livestock Show and Rodeo events at NRG Park.

Alternative Options:

While there are private companies who perform similar services, they do not have the immediate law enforcement response when confronting individuals suspected of carrying firearms or explosive devices.
