Request for approval to negotiate with TGI Geotechnics, Inc. for Professional Engineering Services regarding Construction Testing and related Services for East Harris County Healthcare and Social Services Hub - UPIN 21102MF1QB01, Precinct 2.

Background and Discussion:

Acquisition of Property consists of acquiring an existing property at 15430 East Freeway, demolishing the existing foundation/slabs, and Construction of a Healthcare Facility Project which is a new 10,500 SF preengineered metal building on the site. There will also be client & employee parking spaces and a pad for mobile clinic access.

Expected Impact:

The goal of this project is to implement a community-based health services program which includes: mobile health services, new wellness centers, and health hubs to provide affordable, convenient, high quality healthcare services to Harris County residents most in need. This agreement will allow the firm to conduct field and laboratory testing on soil, concrete asphalt, and various other construction materials. This testing will ensure the material's compliance with Harris County Engineering and other governing bodies specifications as required by state law.
