Request for approval to negotiate with Isani Consultants LP. for professional engineering services in connection with Drainage Improvements - McNair Area - 2024, UPIN 24102MF3DT01, Precinct 2.

Background and Discussion:

Harris County Engineering Department (HCED) received a request from Precinct 2 for a drainage improvement project within the McNair Area. The scope of this project includes: H&H Analysis for at least one of three alternatives & identifying potential locations for mitigation volume, preparation of street alignment and typical sections incorporating 6-foot-wide concrete sidewalks and curb ramps at street intersections, preparation of traffic report and pedestrian survey, preparation of construction estimate, preparation of utility conflict list, provide exhibits/renderings for public engagement, environmental, survey, traffic review, and geotechnical tasks.

To provide Precinct 2 with a Preliminary Engineering Report for the McNair Area to meet the Commissioner's Revive2Thrive initiative to provide infrastructure improvements that benefit communities. This project is funded by Precinct 2.
